## SELECT CASES

- **Mittra v Royal Bank of Canada et al** – Counsel to RBC in this \$10 million wrongful dismissal claim. After a three-week trial, the Court held that RBC had just cause to dismiss the plaintiff without notice. Reported at 2024 ONSC 636.
- **Sherwani v Fargher** – Counsel to the successful Defendant Physician at trial in dismissing allegations of defamation and misfeasance of public office arising from the end of the Plaintiff Physician's privileges at West Parry Sound Hospital at a time when the Defendant Physician was Chief of Staff. The action was dismissed by the Trial Judge and costs of \$280,000 awarded to the Defendant Physician.
- **Confidential Matter** – Counsel to investor in arbitration regarding oppression and dissent claims.

- **Bilak et al v The Attorney General of Canada** – Application for Judicial Review challenging the decision of the Minister of Foreign Affairs of Canada to exempt turbines for the NordStream pipeline from Canada's sanctions regime against Russia enacted following Russia's invasion of Ukraine. The Minister's exemption was cancelled following the commencement of the Judicial Review application.
- **Re Solar Income Fund Inc.** – Counsel to a former director and officer in an Ontario Securities Commission enforcement proceeding.
