Highlights from the last few years of her practice provide a small snapshot of her experience and success in court.

Monique successfully represented the University of Toronto in securing an interlocutory injunction to peacefully end a 50-day encampment on Front Campus. She recently appeared at the Supreme Court of Canada representing intervenor, CFA Societies Canada, in an important appeal addressing reporting issuers' disclosure obligations under the *Securities Act*. In *Li v Barber*, she secured an unprecedented Mareva order freezing up to \$20 million of assets and cryptocurrency of Freedom Convoy leaders. Monique was successful trial counsel to Canadian National Railway Company in a complex 6-week Commercial List trial involving employee fraud and breach of fiduciary duty, resulting in a \$10+ million judgment for her client. She also represented Douglas Cardinal in an

injunction to restrain the use in Canada of the Cleveland baseball team's racist name and logo on human rights grounds.

Her outstanding ability as trial counsel has been recognized many times, having received The Douglas K. Laidlaw Award for Excellence in Advocacy, Fellowship in the International Academy of Trial Lawyers, and Toronto Life's Top 50 Most Influential, among others.
